## Business Meetings

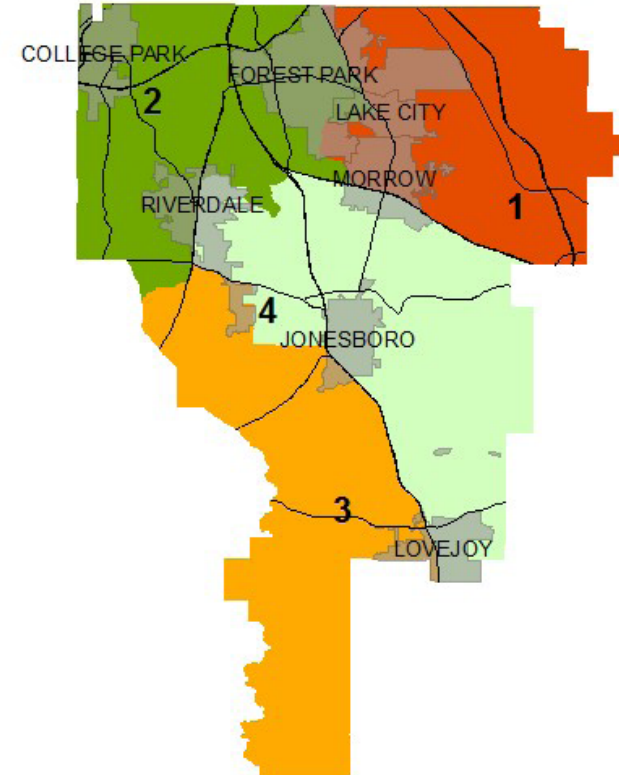
Regular meetings are held on the first and third Tuesday of every month at 7:00 p.m., at 112 Smith Street, Jonesboro, GA.





## Zoning Meetings
