RESOLUTION NO. 2007 - 123

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A SERVICE EXTENSION AGREEMENT WITH THE METROPOLITAN ATLANTA RAPID TRANSIT AUTHORITY, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH SERVICE WILL BE EXTENDED ALONG CAMP CREEK PARKWAY TO CONVENTION CENTER CONCOURSE IN CLAYTON COUNTY TO SERVICE THE GEORGIA INTERNATIONAL CONVENTION CENTER, ROUTE 82; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE DIRECTOR OF TRANSPORTATION AND DEVELOPMENT TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Authority has recognized an opportunity for the extension of existing fixed route bus service provided by MARTA to better serve its patrons; and

WHEREAS, the extension of service has the potential to improve transit mobility, increase rider-ship and improve employment accessibility for patrons in the Authority's service area; and

WHEREAS, Clayton County concurs in the Authority's extension of MARTA Route 82 as described herein to better serve the transit needs of the region's citizens, and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Service Extension Agreement with MARTA to provide for the services contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the County to enter into a Service Extension Agreement with MARTA providing for the terms and conditions under which extended service will be provided with open door service along Camp Creek Parkway to Convention Center Concourse in Clayton County, Route 82 to serve the Georgia International Convention Center operated by the City of College Park, and located partially in Fulton County and partially in Clayton County, with the bus stop location being on Convention Center Concourse in Clayton County. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and to perform all other acts necessary to accomplish the intent of this Resolution. The Board of Commissioners hereby authorizes the Director of Transportation and Development to perform all acts necessary to accomplish the intent of the Resolution. The Agreement shall be subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






