RESOLUTION NO. 2007 - 184

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A DONATION FROM THE LINKS, INCORPORATED, AZALEA CITY CHAPTER ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION, KINSHIP RESOURCE CENTER TO BE USED IN CONNECTION WITH THE GRANDPARENTS RAISING GRANDCHILDREN PROGRAM; TO AUTHORIZE THE CHAIRMAN TO ACCEPT THE DONATION ON BEHALF OF CLAYTON COUNTY AND TO EXECUTE ANY DOCUMENTS NECESSARY, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE OF THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, The Links, Inc., Azalea City Chapter (the "Chapter") wishes to donate \$23,068.00 to the Clayton County Parks and Recreation, Kinship Resource Center (the "Center"); and

WHEREAS, the donated funds will be used to purchase a 15-passenger van to be used solely by the Center for the Grandparents Raising Grandchildren Program; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by the acceptance of the donation from the Chapter for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED






Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






Dear Ms. Burda,
