RESOLUTION NO. 2007 – 62

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO EXERCISE ITS POWERS OF EMINENT DOMAIN IN ACCORDANCE WITH PROVISIONS OF GA. LAWS FOR THE PURPOSE OF ACQUIRING CERTAIN PROPERTIES FOR USE BY THE CLAYTON COUNTY TRANSPORTATION AND DEVELOPMENT DEPARTMENT FOR THE WARREN DRIVE, CONKLE ROAD BRIDGE REPLACEMENT AND ANVIL BLOCK ROAD IMPROVEMENT PROJECTS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County desires to exercise its powers of eminent domain in accordance with provisions of Ga. Laws for the purpose of acquiring certain properties for use by the Clayton County Transportation and Development Department for the Warren Drive Project, specifically Jessie Durham parcel no. 13216CB011, Cedeno Buchanan parcel no. 13216DB004, Norma J. Henderson parcel no. 12077CA003, Brian Cosby parcel no. 13233BA001, David Rojas parcel no. 13233BA001, Burford Black parcel no. 12234CA007, M.S. Zakaria MD parcel no. 13233BA001, Barbara Garrett parcel no. 12234CA006A, Troy D. Meyers, et al parcel no. 12234CA008, South Park Associates parcel no. 12235DA001 & 1A, Reuben Fernandez parcel no. 13216DB003 and Betty Benicoff parcel no. 13216CA002; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by acquiring subject properties for the reasons set forth herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to exercise its powers of eminent domain in accordance with provisions of Ga. Laws for the purpose of acquiring certain properties for use by the Clayton County Transportation and Development Department for the Warren Drive, Conkle Road Bridge Replacement and Anvil Block Road Improvement Projects, specifically Jessie Durham parcel no. 13216CB011, Cedeno Buchanan parcel no. 13216DB004, Norma J. Henderson parcel no. 12077CA003, Brian Cosby parcel no. 13233BA001, David Rojas parcel no. 13233BA001, Buford Black parcel no. 12234CA007, M.S. Zakaria MD parcel no. 13233BA001, Barbara Garrett parcel no. 12234CA006A, Troy D. Meyers, et al parcel no. 12234CA008, South Park Associates parcel no. 12235DA001 & 1A, Reuben Fernandez parcel no. 13216DB003 and Betty Benicoff parcel no. 13216CA002.



Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




