RESOLUTION NO. 2007 - 73

A RESOLUTION TO TRANSFER CERTAIN DIRECTORS AND ASSISTANT DIRECTORS TO CERTAIN DEPARTMENTS WITHIN CLAYTON COUNTY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL DOCUMENTS NECESSARY AND TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT APPROPRIATE REVENUE SOURCES AND EXPENSES FOR THE RESPECTIVE DEPARTMENTAL BUDGETS AND TO MAKE ANY NECESSARY LINE ITEM TRANSFERS, ALL AS MAY BE REQUIRED TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE PERSONNEL DIRECTOR TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE TRANSFER OF THE RESPECTIVE PERSONNEL AND TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners desires to increase the effectiveness and efficiency of the county government by transferring certain directors; and

WHEREAS, Eddie Williams, current Director of Community Development will be transferred to Refuse Control to hold the position of Director to serve the members of the Clayton County Board of Commissioners; and

WHEREAS, Donnie Hood, current Director of Building and Maintenance will be transferred to Community Development to hold the position of Director to serve the members of the Clayton County Board of Commissioners; and

WHEREAS, the pay grade for Eddie Williams and Donnie Hood will remain the same as in their previous positions; and

WHEREAS, Les Markland, current Assistant Director of Building and Maintenance, will be promoted and hold the position of Interim Director of Building and Maintenance, and will be moved from a pay grade 29 to a pay grade 33, to serve the members of the Clayton County Board of Commissioners; and

WHEREAS, Wayne Lee, current Director of Refuse Control, will be transferred to Building and Maintenance and hold the position of Assistant Director to serve the members of the Clayton County Board of Commissioners; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by the reappointments of personnel as outlined above.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby transfers and appoints Eddie Williams to Director of Refuse Control, Donnie Hood to Director of Community Development, Les Markland is promoted to Interim Director of Building and Maintenance with a pay grade increase to 33, and Wayne Lee to Assistant Director of Building and Maintenance, and will perform all duties as authorized pursuant to such policies, rules and regulations of the Clayton County Board of Commissioners as now or hereafter adopted, and shall also direct any other

appointments so designated by the Clayton County Board of Commissioners and perform such reasonable duties and responsibilities as from time to time may now or hereafter be assigned to the respective Directors of Clayton County. The Board of Commissioners authorizes the pay grade for Eddie Williams and Donnie Hood to remain the same as in their previous positions. The Board of Commissioners hereby authorizes the Chairman to execute all documents necessary and to perform all other acts necessary to accomplish the intent of the resolution. Further, the Board of Commissioners authorizes the Finance Director to amend the budget where necessary to reflect appropriate revenue sources and expenses for the respective departmental budgets and to make any necessary line item transfers, all as may be required to accomplish the intent of this resolution. The Board of Commissioners authorizes the Personnel Director to perform all acts necessary to accomplish the transfer of the respective personnel and to perform all acts necessary to accomplish the intent of this resolution.


Section 2. This Resolution shall be effective on the next regular payroll cycle from today's date, Monday, May 7<sup>th</sup>, 2007.






