RESOLUTION NO. 2008 - 121

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ADVOCACY FOUNDATION, INC. ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE "BUILDING RESILIENT YOUTH – A MULTI-DISCIPLINARY APPROACH" PROGRAM WILL BE CONDUCTED AT THE CARL RHODENIZER RECREATIONAL FACILITY IN REX, GEORGIA; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally endorsed and supported the work of various nonprofit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the County has expressed interest in collaborating with The Advocacy Foundation, Inc. to facilitate the "Building Resilient Youth – A Multi-Disciplinary Approach" program to be conducted from July 1, 2008 through June 30, 2009 at the Carl Rhodenizer Recreational Facility in Rex, Georgia and consisting of a multi-disciplinary, multifaceted program with the purpose of promoting, "at-risk" youth to "at-promise" youth via a wide range of community engagement, educational support, mentorship, and internship opportunities; and

WHEREAS, The Advocacy Foundation, Inc. is qualified to organize and facilitate projects that promote and inspire excellence in youth services, and there will be no funding required of the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Memorandum of Understanding as contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into a Memorandum of Understanding on behalf of the Clayton County Parks and Recreation Department with The Advocacy Foundation, Inc. providing for the terms and conditions under which the "Building Resilient Youth – A Multi-Disciplinary Approach" program to be conducted from July 1, 2008 through June 30, 2009 at the Carl Rhodenizer Recreational Facility in Rex, Georgia. The Board of Commissioners hereby authorizes the Chairman to execute the Memorandum of Understanding and to perform all other acts necessary to accomplish the intent of this Resolution. The Memorandum of Understanding shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


