RESOLUTION NO. 2008 - 46

A RESOLUTION TO PROVIDE FOR A CHANGE IN THE NAME OF THE PUBLIC ROAD RIGHT-OF-WAY OF SHERI COURT IN THE DEVELOPMENT OF POPLAR RIDGE SUBDIVISION, CLAYTON COUNTY, GEORGIA, TO HARLESS COURT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY REQUIRED DOCUMENTS, AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in the interest of public safety and well being, the Board of Commissioners proposes to rename Sheri Court in the development of Poplar Ridge Subdivision, Clayton County, Georgia, to Harless Court; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by renaming the public road right-of-way of Sheri Court in the development of Poplar Ridge Subdivision, Clayton County, Georgia, to Harless Court.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to rename Sheri Court in the development of Poplar Ridge Subdivision, Clayton County, Georgia, to Harless Court. The Board of Commissioners hereby authorizes the Chairman to


execute all required documents, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.



SO RESOLVED, this the 18<sup>th</sup> day of March, 2008.


