RESOLUTION NO. 2008 - 99

A RESOLUTION TO AMEND RESOLUTION 2008 - 56 ADOPTING A MORATORIUM ON THE ACCEPTANCE OF APPLICATIONS FOR LAND USE AMENDMENTS, AS WELL AS APPLICATIONS FOR REZONING OF PARCELS OF LAND OR BUILDINGS, AS THEY RELATE TO EXISTING OR PROPOSED PROPERTIES WITHIN ALL ZONING DISTRICTS WITHIN CLAYTON COUNTY LOCATED ON PROPERTY FRONTING ON TARA BLVD (HWY 19/41) SOUTHWARD FROM ITS INTERSECTION WITH UPPER RIVERDALE ROAD AND CONTINUING SOUTHWARD TO THE HENRY COUNTY LINE WITH THE EXCEPTION OF THOSE AREAS INCLUDED WITHIN THE CITY LIMITS OF EITHER JONESBORO OR LOVEJOY; TO BE IN EFFECT FROM ENACTMENT, THROUGH AND INCLUDING JULY 23, 2008, OR EARLIER; TO ADOPT AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County previously approved Resolution 2008 - 56 adopting a Moratorium on the acceptance of applications for land use amendments, as well as applications for rezoning of parcels of land or proposed properties within all zoning districts within Clayton County located on property fronting on Tara Boulevard (Highway 19/41) southward from its intersection with Upper Riverdale Road and continuing southward to the Henry County line with the exception of those areas included within the city limits of either Jonesboro or Lovejoy;

and

WHEREAS, the suspension for the acceptance of applications for land use amendments and the rezoning of parcels of land or buildings relating to existing or proposed properties was set to expire on June 20, 2008; and

WHEREAS, the Board of Commissioners deems it in the County's best interest and the objectives provided herein can be best served by amending Resolution 2008-56 to provide that the above referenced Moratorium should remain in effect through and including July 23, 2008, with all other terms of the previous Resolution remaining the same.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. Resolution 2008-56 is amended to be extended through and including July 23, 2008. All other terms of Resolution 2008-56 shall remain the same.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.





RESOLUTION NO. 2008-100

A RESOLUTION TO AMEND RESOLUTION 2008-57 ADOPTING A MORATORIUM ON THE ACCEPTANCE OF APPLICATIONS FOR LAND USE AMENDMENTS, AS WELL AS APPLICATIONS FOR REZONING OF PARCELS OF LAND OR BUILDINGS, AS THEY RELATE TO EXISTING OR PROPOSED RESIDENTIAL PROPERTIES WITHIN ALL ZONING DISTRICTS WITHIN CLAYTON COUNTY TO BE IN EFFECT FROM JUNE 20, 2008, THROUGH AND INCLUDING JULY 23, 2008, TO ADOPT AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County previously approved Resolution 2008-57 extending the previously adopted Moratorium on the acceptance of applications for land use amendments as well as applications for rezoning of parcels of land or buildings as they relate to existing or proposed residential properties within all zoning districts in the county; and

WHEREAS, the suspension for the acceptance of applications for land use amendments and the rezoning of parcels of land or buildings relating to existing or proposed residential properties was set to expire on June 20, 2008; and

WHEREAS, the Board of Commissioners deems it in the County's best interest and the objectives provided herein can be best served by amending Resolution 2008-57 to provide that the above referenced Moratorium should remain in effect through and including July 23, 2008, with all other terms of the previous Resolution remaining the same.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
