RESOLUTION NO. 2009 – 166

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO EXERCISE ITS POWERS OF EMINENT DOMAIN IN ACCORDANCE WITH PROVISIONS OF GA. LAWS FOR THE PURPOSE OF ACQUIRING CERTAIN PROPERTIES FOR USE BY THE CLAYTON COUNTY TRANSPORTATION AND DEVELOPMENT DEPARTMENT FOR THE PANOLA ROAD WIDENING PROJECT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

Andamson, parcel 9, tax identification no. 12183BB007, Mr. and Mrs. O.H. Andamson, parcel 10, tax identification no. 12183DA002, John E. Jones, parcel 34, tax identification no. 12184DB009, Sumner Hutcheson IV, parcel 35, tax identification no. 12184BA053, and John R. Landers, parcel 80, tax identification no. 12185CA001A; and

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED



Andamson, parcel 9, tax identification no. 12183BB007, Mr. and Mrs. O.H. Andamson, parcel 10, tax identification no. 12183DA002, John E. Jones, parcel 34, tax identification no. 12184DB009, Sumner Hutcheson IV, parcel 35, tax identification no. 12184BA053, and John R. Landers, parcel 80, tax identification no. 12185CA001A. Further, the Board of Commissioners hereby authorizes the Chairman to execute any document relating thereto, and otherwise to perform all acts necessary to accomplish the intent of this Resolution. The properties sought to be acquired are more fully depicted on Exhibit "A" attached hereto.
