RESOLUTION NO. 2010 - 241

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO AMEND THE EXISTING 2010 HOME PROGRAM SUBRECIPIENT AGREEMENT BETWEEN CLAYTON COUNTY AND THE JONESBORO HOUSING AUTHORITY TO INCLUDE DELIVERY OF SERVICES COSTS AS PART OF THE FUNDING PROVIDED TO THE JONESBORO HOUSING AUTHORITY; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION, TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED, TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Jonesboro Housing Authority (JHA) presently operates the HOME Program funded Clayton Housing Assistance Program (CHAP), a down payment assistance program targeted for HOME Program eligible homebuyers and did receive \$50,000 for service delivery costs as per Resolution No. 2009-201, through its Clayton Housing Assistance Program (CHAP), and

WHEREAS, the JHA is about to exhaust their CHAP service delivery funding; and

WHEREAS, the JHA received \$300,000 in PY 2010 HOME funds for the CHAP but none of these funds were designated for service delivery costs/operating costs for JHA in their 2010 subrecipient agreement; and

WHEREAS, Clayton County desires that the CHAP be continued by the JHA, and is willing to reallocate a sufficient amount of the PY 2010 down payment assistance funding already provided to the JHA to pay for service delivery

expenses, not to exceed \$55,000, that JHA will incur operating the CHAP for Clayton County during 2011; and

WHEREAS, Clayton County is agreeable to amending its 2010 subrecept agreement with JHA to authorize this reallocation; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and CHAP to support this reallocation.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HERBEY RESOLVED.

Section 1. The Board of Commissioners hereby authorizes the amendment of the 2010 Subrecept Agreement between Clayton County and the Jonesboro Housing Authority to allow \$ 55,000 of the \$300,000 HOME Program down payment assistance funding, previously awarded to JHA in PY 2010, to be used also to pay the salary and benefits of the staff person who administers /delivers the services needed to operate CHAP, as well as costs necessary to carry out the aid of down payment assistance through CHAP. HUD regulations permit HOME funds to be used to pay costs to operate/deliver eligible program activities such as down payment assistance.


Section2. This Resolution shall be effective on the date of its approval by the Clayton County Board of Commissioners.


