RESOLUTION NO. 2010- 81

A RESOLUTION AUTHORIZING THE COUNTY TO ACCEPT A GRANT AWARD OF \$54,000.00 FROM THE UNITED STATES DEPARTMENT OF JUSTICE CRIMINAL JUSTICE COORDINATING COUNCIL AWARDED UNDER THE 2009 AMERICAN RECOVERY AND REINVESTMENT ACT, AND THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT. NO COUNTY MATCHING FUNDS ARE REQUIRED. FUNDING WILL BE USED TO INCREASE THE TECHNOLOGICAL CAPABILITIES OF THE POLICE DEPARTMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Criminal Justice Coordinating Council has awarded a \$54,000.00 grant to the Clayton County Police Department to provide for computer equipment, and software to further enhance police operations and training, and

WHEREAS, these supplemental funds are being awarded to the Clayton County Police Department with no matching County funds, and at no cost to the citizens of Clayton County: and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said award.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HERBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept a \$54,000.00 grant from the United States Department of Justice Criminal Justice Coordinating Council awarded under the 2009 American Recovery and Reinvestment Act, and The Edward Byrne Memorial Justice Assistance Grant, to provide for computer equipment and software to further enhance police operations and training. The Board of Commissioners also authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the grant.

Section 2. This resolution shall be effective on the date of its approval by the Board of Commissioners.




