RESOLUTION NO. 2010 – 84

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF ONE CONDEMNED VEHICLE TO BE ASSIGNED TO THE CLAYTON COUNTY SHERIFF'S DEPARTMENT FLEET; TO AUTHORIZE THE ACCEPTANCE AND SALE OF ONE CONDEMNED VEHICLE AT PUBLIC AUCTION; TO PROVIDE FOR THE DISBURSAL OF SALE PROCEEDS, ALL IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Department seized two 1999 Jeep Grand Cherokees after having been used to facilitate a violation of the Georgia Controlled Substance Act, VIN# 1J4GW68N1XC597226 and VIN# 1J4G268S9XC757919; and

WHEREAS, the Clayton County Sheriff's Department did petition the District Attorney for forfeiture of said vehicles to the County; and

WHEREAS, the Superior Court of Clayton County has forfeited ownership and title of said vehicles to the County under court order in case number 2009-CV-02053-5; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicle bearing VIN# 1J4G268S9XC757919 is suitable for service as a County vehicle after installation of a battery and routine preventive maintenance at a cost of \$300.00; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicle bearing VIN# 1J4GW68N1XC587226 is not suitable for service as a County vehicle and should be sold at public auction; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will be best served by accepting said vehicle bearing VIN#

1J4G268S9XC757919 and assigning it to the Clayton County Sheriff's Department fleet to enhance law enforcement in accordance with applicable State statutes, and to accept said vehicle bearing VIN# 1J4GW68N1XC587226 to be sold at public auction.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED



The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


