RESOLUTION NO. 2010 - 87

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AGREEMENT WITH ATLANTA PYROTECHNICS INTERNATIONAL, INC. PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH A FIREWORKS DISPLAY WILL BE CONDUCTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, Atlanta Pyrotechnics International, Inc. desires to conduct a fireworks display on May 29, 2010, July 4, 2010 and September 4, 2010, to be held at the Clayton County International Park; and

WHEREAS, the County's Parks and Recreation Department shall have sole responsibility for promoting and providing security for protection at the fireworks display to be held at the Clayton County International Park May 29, 2010, July 4, 2010 and September 4, 2010; and

WHEREAS, Atlanta Pyrotechnics International, Inc. is qualified to organize and conduct fireworks displays in a professional, safe and organized manner; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into an agreement with Atlanta Pyrotechnics International, Inc.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into an agreement with Atlanta Pyrotechnics International, Inc. providing for the terms and conditions under which a fireworks display will occur on May 29, 2010, July 4, 2010 and September 4, 2010 at the Clayton County International Park. The Board also authorizes the County's Parks and Recreation Department to promote and provide security for protection at the fireworks display to be held at the Clayton County International Park on May 29, 2010, July 4, 2010 and September 4, 2010.

Section 2. The Board of Commissioners authorizes the Chairman to execute the agreements attached hereto as Attachments "A" and "B", including the addendums, and otherwise perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Finance Director to amend the budget where necessary to reflect appropriations and expenditures relating thereto.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


