RESOLUTION NO. 2010 - 96

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT GRANT FUNDS AWARDED BY THE CLAYTON COUNTY BOARD OF HEALTH ON BEHALF OF THE CLAYTON COUNTY EMERGENCY MANAGEMENT AGENCY IN THE AMOUNT OF \$10,000.00 FOR THE PURPOSE OF MAINTAINING AND ENHANCING THE CLAYTON COUNTY COMMUNITY EMERGENCY RESPONSE TEAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL DOCUMENTS NECESSARY, AND TO OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Emergency management Agency ("CCEMA") has been awarded a grant in the amount of \$10,000.00 by the Clayton County Board of Health for the purpose of maintaining and enhancing the Clayton County Community Emergency Response Team ("CERT"); and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by accepting the grant funds as described herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED






Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.

SO RESOLVED, this the 20<sup>th</sup> of April, 2010.


