RESOLUTION NO. 2011 - 164

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST FOR CLAYTON COUNTY ASSOCIATION AGAINST FAMILY VIOLENCE, INC., TO SPONSOR AND HOST A DOMESTIC VIOLENCE CONFERENCE AT THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE PARKS AND RECREATION DEPARTMENT TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from Clayton County Association Against Family Violence, Inc. a/k/a Secur'us House (the "Request") for use of the Virginia Burton Gray Recreation Center (the "Center") for the purpose of hosting a Domestic Violence Conference on October 22, 2011 from 8:00 a.m. and 4:00 p.m., for fundraising to support the programs of Secur'us House; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request of the Park space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED




