RESOLUTION NO. 2011 - 53

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW PROJECT REAL LIFE YOUTH OCCUPATIONAL TRAINING CORPS, INC. TO HOST AND SPONSOR THE "MAMA NEM COOK-OFF" COMPETITION AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from Project Real Life Youth Occupational Training Corps, Inc. (the "Promoter") for use of space at the St. Thomas and St. Vincent Pavilions at Clayton County International Park (the "Location") for the purpose of holding a fundraising event entitled, "Mama Nem Cook-Off"; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Promoter wishes to utilize the Location on July 2, 2011 for the cooking competition, live musical entertainment, promotional and selling vendors, food vendors and children's activities such as moonwalks and face painting and other games; and

WHEREAS, the Promoter is qualified to organize and facilitate projects that contribute positively to the community's morale and promote community involvement by offering positive, family-friendly cultural and musical entertainment; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host and sponsor this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED




Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


