RESOLUTION NO. 2011 - 70

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH ITS PARKS AND RECREATION DEPARTMENT, TO ALLOCATE FUNDS TO PAY THE EXPENSES FOR A SITE VISIT BY THE COMMISSION FOR ACCREDITATION OF PARK AND RECREATION AGENCIES (CAPRA); TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE PARKS AND RECREATION DEPARTMENT TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED BY CAPRA; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County desires for its Parks and Recreation Department to obtain accreditation by the Commission for Accreditation of Park and Recreation Agencies (CAPRA) to establish nationally that it delivers a high level of quality programs and services to its constituents; and

WHEREAS, CAPRA accreditation is a five-year cycle consisting of three phases, one of which is an on-site visit by three CAPRA representatives to take place between July 31, 2011 and August 4, 2011; and

WHEREAS, the Parks and Recreation Department is responsible for covering the expenses for travel, room and the per diem allowance of the three CAPRA representatives conducting the site visit; and

WHEREAS, the Parks and Recreation Department's FY 2011 approved budget included the payment of the above expenses, not to exceed a total of \$5,000.00; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by authorizing the Parks and Recreation Department to allocate funds to pay the expenses for the CAPRA site visit for the purposes above.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED:


Section 1. The Clayton County Board of Commissioners authorizes the County, through its Parks and Recreation Department, to allocate funds to pay the expenses for an on-site visit by the Commission for Accreditation of Park and Recreation Agencies (CAPRA). The Board of Commissioners hereby authorizes the Chairman and the Director of the Parks and Recreation Department to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required by CAPRA.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






