RESOLUTION NO. 2011 - 92

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AFFILIATION AGREEMENT AND CONTRACT FOR SERVICES ON BEHALF OF THE CLAYTON COUNTY JUVENILE COURT WITH THE GEORGIA COURT APPOINTED SPECIAL ADVOCATE ASSOCIATION TO ACCEPT GRANT FUNDS AND TO SET FORTH THE TERMS AND CONDITIONS UNDER WHICH THE GRANT FUNDS WILL BE UTILIZED; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND CONTRACT FOR SERVICES, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET TO REFLECT THE APPROPRIATION AND EXPENSES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through its Juvenile Court applied for and was approved to receive grant funds in the amount of \$38,249.03 from the Georgia Court Appointed Special Advocate Association; with no match required from Clayton County; and

WHEREAS, the grant period is July 1, 2011 to June 30, 2012; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Affiliation Agreement and Contract for Services for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into an Affiliation Agreement and Contract for Services on behalf of the Clayton County Juvenile Court with the Georgia Court Appointed Special Advocate Association, and in accordance therewith accept

grant funds in the amount of \$38,249.03. The Board of Commissioners hereby authorizes the Chairman to execute the Affiliation Agreement and Contract for Services, and otherwise to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Finance Director to amend the budget to reflect the appropriation and expenses relating thereto. The Affiliation Agreement and Contract for Services shall be substantially in the form attached hereto.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
