RESOLUTION NO. 2011 - 94

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A CONTRACT AMENDMENT WITH THE GEORGIA DEPARTMENT OF HUMAN RESOURCES ON BEHALF OF THE CLAYTON COUNTY EXTENSION SERVICE, AND IN ACCORDANCE THEREWITH AMEND THE GRANT PERIOD FOR THE PROMOTING SAFE AND STABLE FAMILIES, ABC'S OF PARENTING PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE CONTRACT, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, AND TO TRANSFER ANY REQUIRED MATCH OF LOCAL FUNDS, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Department of Human Resources ("DHR") allocated federal grant funds in the amount of \$22,210.08, with a match from Clayton County in the amount of \$7,403.36 on behalf of the Clayton County (the "COUNTY") Extension Service Promoting Safe and Stable Families, ABC's of Parenting Program, with an original grant period of October 1, 2010 to June 30, 2011; and

WHEREAS, the County and DHR wish to amend the grant period to begin on October 1, 2010 and terminate on September 15, 2011; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Contract Amendment with the Georgia Department of Human Resources for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Contract Amendment with the Georgia Department of Human Resources, and in accordance therewith amend the grant period to begin on October 1, 2010 and terminate on September 15, 2011 for the Promoting Safe and Stable Families, ABC's of Parenting Program. The Board of Commissioners hereby authorizes the Chairman to execute the Contract Amendment, and otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, and to transfer any required match of local funds, all as may be required under the terms of the Contract. The Contract shall be in substantially the form attached hereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




