RESOLUTION NO. 2012 – 112

A RESOLUTION AUTHORIZING JUVENILE COURT, ON BEHALF OF CLAYTON COUNTY, TO SUBMIT AN APPLICATION TO THE GEORGIA DEPARTMENT OF HUMAN RESOURCES TO RECEIVE GRANT FUNDS IN CONNECTION WITH THE PROMOTING SAFE AND STABLE FAMILIES PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE APPLICATION, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, AND TO TRANSFER ANY REQUIRED MATCH OF LOCAL FUNDS, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through the Clayton County Juvenile Court, desires to submit a Grant Application to the Georgia Department of Human Resources (“GDHR”) to receive funding for program services to be used in connection with the Promoting Safe and Stable Families Program; and

WHEREAS, if awarded, the grant funds will total \$51,075, and will require a 25% local match of funds in the amount of \$17,025; and

WHEREAS, the contract period for the grant will be from October 1, 2012, through September 30, 2013; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by submitting a Grant Application to the Georgia Department of Human Resources for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to submit a Grant Application to the Georgia Department of Human Resources to receive funds to be used in connection with the Promoting Safe and Stable Families Program. The Board of Commissioners hereby authorizes the Chairman to execute the Application, and otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, and to transfer any required match of local funds, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


