RESOLUTION NO. 2012 - 178

A RESOLUTION AUTHORIZING CLAYTON COUNTY ON BEHALF OF CLAYTON COUNTY FIRE & EMERGENCY SERVICES, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE U.S. MARSHAL'S OFFICE TO PARTICIPATE IN A REGIONAL FUGITIVE TASK FORCE; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; ALL AS MAY BE REQUIRED IN THE TERMS OF THE MEMORANDUM OF UNDERSTANDING; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the U.S. Marshal's Office ("USMS") operates a Regional Fugitive Task Force with participation from various area law enforcement agencies; and

WHEREAS, Clayton County Fire & Emergency Services' Tactical Medic Program has been recognized at the local, state and federal level for its effectiveness in providing both officer and offender emergency medical care and has become a model for similar programs; and

WHEREAS, USMS seeks to partner with Clayton County Fire & Emergency Services ("CCFES") to provide medical support and training to the Regional Fugitive Task Force; and

WHEREAS, entering into a Memorandum of Understanding ("MOU") with USMS would allow CCFES to be reimbursed for training provided to USMS staff; and

WHEREAS, USMS will also reimburse the County for overtime payments subject to the availability of funds; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by participating in this Regional Fugitive Task Force and entering into this MOU for the stated reasons.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County on behalf of Clayton County Fire & Emergency Services, to enter into a Memorandum of Understanding with the U.S. Marshal's Office to participate in a Regional Fugitive Task Force. The Board authorizes the Chairman, or the Fire Chief as the Chairman's designee, to execute the Memorandum of Understanding. The Board of Commissioners also authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the agreement.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.

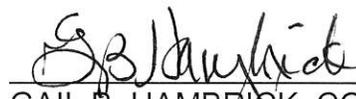

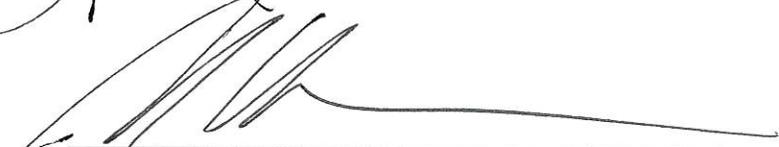
