RESOLUTION NO. 2012 - 193

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY DEPARTMENT OF SENIOR SERVICES, TO GRANT A SPECIAL FACILITY USE REQUEST FOR CLAYTON COUNTY GRASSROOTS LEADERSHIP INSTITUTE TO USE SPACE AT THE J. CHARLEY GRISWELL SENIOR CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Department of Senior Services received a Special Facility Use Request from Clayton County Grassroots Leadership Institute (the "Request") for use of the J. Charley Griswell Senior Center (the "Center") for the purpose of hosting its annual graduation ceremony; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Center space will be utilized between the hours of 5:00 p.m. and 9:30 p.m. on Thursday, November 1, 2012; and

WHEREAS, Clayton County Department of Senior Services also requests all fees associated with the use of the Center be waived; and

WHEREAS, Clayton County Department of Senior Services will provide two staff members to monitor the program and building; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request of the Center space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS


OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Department of Senior Services, to grant the Clayton County Grassroots Leadership Institute, a Special Facility Use Request to host its annual graduation ceremony at the J. Charley Griswell Senior Center, and also authorizes the Chairman to execute any documents necessary, and otherwise perform all acts necessary to accomplish the intent of this Resolution.
