RESOLUTION NO. 2012 - 201

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO COLLABORATE WITH COUNTY AGENCIES AND REPRESENTATIVES IN SUPPORT OF THE KIDS OUTDOORS INITIATIVE AND THE GEORGIA CHILDREN'S OUTDOOR BILL OF RIGHTS, AND TO SPONSOR THE 4TH ANNUAL CLAYTON COUNTY PARKS AND RECREATION/LAKE SPIVEY ROAD RACE FOR THE KIDS OUTDOORS INITIATIVE AT THE FIRST CHRISTIAN CHURCH; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, with recent concerns about youth detachment from outdoor activities, lack of physical exercise and increased health risks, the Georgia Recreation and Park Association, Inc. adopted the Georgia Children's Outdoor Bill of Rights; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, in collaboration with County agencies, elected officials and non-profit organizations, the Director of the County's Parks and Recreation Department desires to sponsor on November 3, 2012, the "4th Annual Parks and Recreation/Lake Spivey Road Race" to take place at the First Christian Church located at 2272 Walt Stephens Road in Jonesboro, Georgia as part of the Kids Outdoors Initiative; and

WHEREAS, Clayton County Parks and Recreation Department shares responsibility for organizing, promoting and managing the "4th Annual Parks and Recreation/Lake Spivey Road Race"; and

WHEREAS, the Road Race, consisting of 15K and 5K events, will commence from and finish at the First Christian Church; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by collaborating with County agencies and representatives to sponsor these events.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County, through its Parks and Recreation Department, to collaborate with County agencies, elected officials and non-profit organizations to sponsor the “4th Annual Parks and Recreation/Lake Spivey Road Race” which will occur on November 3, 2012 at First Christian Church as part of the Kids Outdoors Initiative. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


