RESOLUTION NO. 2012 - 225

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH RAINBOW HOUSE, INC. PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE “10<sup>th</sup> ANNUAL FESTIVAL OF TREES AND LIGHTS” EVENT WILL BE CONDUCTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, Rainbow House, Inc., in collaboration with the County's Parks and Recreation Department, desires to sponsor the “10<sup>th</sup> Annual Festival of Trees and Lights” event on November 30, December 1, 2, 7, 8, 9, 14, 15, and 16, 2012, (hereinafter the “event dates”) using the Nassau Building at the Clayton County International Park; and

WHEREAS the event will consist of displays of outdoor lighting, various live performing acts, a “Santa Shop,” concession stand, hay rides and photos with Santa; and

WHEREAS, Rainbow House, Inc., will work in conjunction with the County's Parks and Recreation Department in its responsibility to organize and manage the “10<sup>th</sup> Annual Festival of Trees and Lights” event; and

WHEREAS, members of the public will be charged entrance fees at the event in accordance with a fee splitting arrangement between Rainbow House, Inc. and the County's Parks and Recreation Department; and

WHEREAS, the following revenue split will apply: Parking Fees – Cars: \$7.00 (Rainbow House receives \$3.00), Vans: \$10.00 (Rainbow House receives \$4.00), Buses: \$20.00 (Rainbow House receives \$8.00). Rainbow House will also receive the revenue from the Nassau Building; and

WHEREAS, Rainbow House, Inc. is qualified to organize, promote, and manage the events; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into the agreement with Rainbow House, Inc.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with Rainbow House, Inc. providing for organizing, promoting and managing the “10<sup>th</sup> Annual Festival of Trees and Lights” event, consisting of displays of outdoor lighting, various live performing acts, a “Santa Shop”, concession stand and hay rides, which will occur on November 30, December 1, 2, 7, 8, 9, 14, 15, and 16, 2012, using the Nassau Building at the Clayton County International Park.


