RESOLUTION NO. 2012 – 263

A RESOLUTION AUTHORIZING THE RENAMING OF CERTAIN CLAYTON COUNTY ROADWAYS; TO AUTHORIZE THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT TO ERECT SIGNS ON THE SUBJECT STREETS REFLECTING THE RENAMING; TO AUTHORIZE THE CHAIRMAN TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Department of Transportation and Development (“T&D”) has identified two roadways that need to be renamed in order to provide consistent and uniform addresses for three affected parcels of land; and

WHEREAS, T&D recommends renaming the portion of Clemons Road between Berry Road and Spivey Road to “Greenview Drive”; and

WHEREAS, T&D also recommends renaming the portion of Berry Road between Greenview Drive/Clemons Road and the adjoining dead end to “Greenview Drive”; and

WHEREAS, in an effort to obtain community input regarding the proposed street name changes, T&D contacted the property owners of the affected parcels to gauge the acceptance of the name changes; and

WHEREAS, all of the owners of the affected parcels indicated their support of the proposed name changes;

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by renaming these County roadways for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes renaming the portion of Clemons Road between Berry Road and Spivey Road to "Greenview Drive" and renaming the portion of Berry Road between Greenview Drive/Clemons Road and the adjoining dead end to "Greenview Drive". The Board also authorizes the Department of Transportation and Development to erect signs on the subject streets that reflect the renaming. The Board further authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this resolution. The Board also authorizes the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


