RESOLUTION NO. 2013 – 123

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A SEIZED VEHICLE PURSUANT TO A CLAYTON COUNTY SUPERIOR COURT JUDGMENT AND ORDER OF FORFEITURE AND DISPOSITION OF PROPERTY; TO AUTHORIZE ASSIGNMENT OF SUCH VEHICLE TO THE SHERIFF'S OFFICE FLEET; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER OR THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Office seized a 2005 Jeep Grand Cherokee, VIN #1J4GR48K85C506080 during a drug investigation; and

WHEREAS, the Sheriff's Office did petition the District Attorney for forfeiture of said vehicle to the County; and

WHEREAS, the Superior Court of Clayton has forfeited ownership and title of said vehicle to the County under a court order in Case Number 2012-CV-03261-9; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicle is suitable for service as a County vehicle and will be used in Fugitive/Vice operations; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said vehicle and assigning it to the Clayton County Sheriff's Office to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to a 2005 Jeep Grand Cherokee, VIN #1J4GR48K85C506080 and to assign said vehicle to the

Sheriff's Office vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court order case number 2012-CV-03261-9. The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




