RESOLUTION NO. 2013 – 147

A RESOLUTION PROVIDING FOR SUPPLEMENTAL COMPENSATION OF THE CLAYTON COUNTY INTERIM LIBRARY DIRECTOR AS AN EMPLOYEE OF THE STATE OF GEORGIA EMPLOYED IN COUNTY OFFICES AND PERFORMING DUTIES AND RESPONSIBILITIES ESSENTIAL TO COUNTY OPERATIONS; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER OR FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE ALL AS MAY BE REQUIRED; TO PROVIDE AND EFFECTIVE DATE OF THIS RESOLUTION; TO REPEAL CONFLICTING LAWS; AND FOR OTHER PURPOSES.

WHEREAS, Yvonne Carmicheal was named Clayton County Interim Library Director effective March 18, 2013; and

WHEREAS, Ms. Carmicheal is currently a State paid Assistant Library Director but is employed by Clayton County and performs duties and responsibilities essential to County operations; and

WHEREAS, additional compensation for these responsibilities is warranted; and

WHEREAS, it appears to be in the best interest of Clayton County to establish and otherwise authorize additional compensation for Ms. Carmicheal beginning March 18, 2013, and continuing until she no longer performs the duties of Interim Library Director.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby establishes and authorizes additional compensation for Yvonne Carmicheal as the Clayton County Interim Library Director in the amount of \$716.18 per pay period beginning March 18, 2013, and

continuing until Ms. Carmicheal no longer performs the duties of Interim Library Director. The Board authorizes the Chief Financial Officer or the Finance Director to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall become effective upon its approval by the Board of Commissioners.
