RESOLUTION NO. 2013 – 192

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO THE 2013 CLAYTON COUNTY SERVICE DELIVERY STRATEGY AGREEMENT WITH THE CITIES OF COLLEGE PARK, FOREST PARK, JONESBORO, LAKE CITY, LOVEJOY, MORROW AND RIVERDALE, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH LOCAL GOVERNMENT SERVICES WILL BE RENDERED TO THE CITIZENS OF THE COUNTY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to O.C.G.A. Title 36, Chapter 70, Sections 20 through 28, each County and Municipality is required to execute an agreement for the implementation of a local government service delivery strategy; and

WHEREAS, representatives of Clayton County, the Cities of College Park, Forest Park, Jonesboro, Lake City, Lovejoy, Morrow and Riverdale have discussed the implementation of such an agreement; and

WHEREAS, the 2013 Clayton County Service Delivery Strategy Agreement (“SDS Agreement”) constitutes such an agreement and promotes the delivery of local government services in the most efficient, effective and responsive manner for all residents and property owners throughout the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the SDS Agreement with the Cities for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into the 2013 Clayton County Service Delivery Strategy Agreement with the Cities of College Park, Forest Park, Jonesboro, Lake City, Lovejoy, Morrow and Riverdale to be effective upon approval and execution by the requisite number of Cities and continuing until the expiration of such by operation of law, including any extension thereof by virtue of the dispute resolution provisions of the statute, and all the agreements attached as Exhibits shall continue in effect for so long as the Agreement shall continue.

Section 2. The County and the Cities hereby incorporate the following documents, which are attached hereto, as part of the Agreement:

- Clayton County SDS Agreement Exhibits A – G
- Clayton County SDS Forms 1 - 4

Section 3. The Board hereby authorizes the Chairman to execute the SDS Agreement, any and all Agreement Exhibits, and the SDS Forms. The Board further authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this Resolution.


Section 4. This Resolution shall be effective upon its approval by the Board of Commissioners.


