RESOLUTION NO. 2013 – 203

A RESOLUTION TO APPROVE A SPECIAL FACILITY USE REQUEST TO ALLOW GREATER SOLID ROCK BAPTIST CHURCH TO HOST A FISH FRY FUNDRAISER AT FLAT SHOALS PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Greater Solid Rock Baptist Church (the “Host”) wishes to utilize a pavilion at Flat Shoals Park (the “Location”) to host a Fish Fry Fundraiser on August 10, 2013 from 10:00 a.m. until 4:00 p.m.; and

WHEREAS, the Host requested that all fees for use of the pavilion at the Location be waived, however, the Director of the Parks and Recreation Department (the “Department”) is requesting consideration by the Board of Commissioners to approve the Department’s pavilion cost of \$40.00 per hour, two-hour minimum, and \$10.00 per hour thereafter, with Host receiving 50 percent off the total cost as a 501(c)(3) organization; and

WHEREAS, Clayton County deems it in the best interest of the County and the County will best be served by allowing the Host to facilitate this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby agrees to allow Greater Solid Rock Baptist Church (the “Host”) to host a Fish Fry Fundraiser at Flat Shoals Park on August 10, 2013 from 10:00 a.m. until 4:00 p.m. The Board authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the rate of \$40.00 per hour, two-hour minimum, and \$10.00 per hour thereafter, with Host receiving 50 percent off the total cost as a 501(c)(3) organization in connection with the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the event date as provided by the Clayton County Risk Management Department.
