RESOLUTION NO. 2013- 326

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW THE CITY OF MORROW TO INSTALL AN IRON GATE AND BIKE RACK AT THE SOUTHERN MAINTENANCE ENTRANCE TO REYNOLDS NATURE PRESERVE IN CLAYTON COUNTY; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Morrow (the "City") desires to install an iron gate and bike rack at the Southern maintenance entrance to Reynolds Nature Preserve as part of the pedestrian trail connection to this entrance located in Morrow's jurisdiction,

WHEREAS, the City has agreed to install both the gate and bicycle rack at no cost to the County with future maintenance cost funded through Parks and Recreation's annual budget; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served authorizing the installation of an iron gate and bike rack for the above-stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to allow the City of Morrow to install an iron gate and bike rack at the Southern maintenance entrance to Reynolds Nature Preserve, with no estimated installation cost to the County.

Section 2. The Board of Commissioners hereby authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




