RESOLUTION NO. 2013 - 75

A RESOLUTION TO ALLOW REPRESENTATIVES OF THE BROOK MANOR/LEE SUBDIVISIONS TO HOST A NEIGHBORHOOD WATCH MEETING AT THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE PARKS AND RECREATION DEPARTMENT TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, representatives of the Brook Manor/Lee Subdivisions (the "Host") wish to utilize the Virginia Burton Gray Recreation Center (the "Location") to host a Neighborhood Watch Meeting to discuss issues affecting their neighborhood; and

WHEREAS, the Host wishes to utilize the Location in Riverdale, Georgia on March 21, 2013 from approximately 7:00 P.M. until 8:00 P.M., with the intent of having ongoing meetings at the Location; and

WHEREAS, there will be no impact on County staff or programming services; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Host to facilitate this meeting.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners agrees to allow representatives of the Brook Manor/Lee Subdivisions to host a Neighborhood Watch Meeting on March 21, 2013 at the

Virginia Burton Gray Recreation Center to host to discuss issues affecting their neighborhood. The Board of Commissioners authorizes the Chairman and the Director of the Parks and Recreation Department to perform all acts necessary to accomplish the intent of this Resolution.
