RESOLUTION NO. 2013 - 83

A RESOLUTION TO APPROVE RATES PROPOSED BY THE PARKS AND RECREATION DEPARTMENT TO BE CHARGED FOR THE SPECIAL FACILITY USE REQUEST SUBMITTED BY LAKE SPIVEY COMMUNITY, INC. TO HOST A DINNER EVENT AT THE INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS NECESSARY AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Lake Spivey Community, Inc., a registered home owners association with 501(c)(4) status (the "HOA"), submitted a Special Facility Use Request to the Parks and Recreation Department to host a dinner event with a variety show, exhibiting talent from its surrounding area, on September 14, 2013 at the Clayton County International Park (the "Event"), and

WHEREAS, the HOA requested that all fees for use of County property to host the Event be waived; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended and reduced rates totaling ~~\$3,835.00~~ to be charged in connection with the Event; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting and approving the rates proposed by

the Department to be charged to the Organizer in connection with the Event as contemplated herein.

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby approves the rates totaling \$3,835.00 proposed and to be charged by Clayton County's Parks and Recreation Department to Lake Spivey Community, Inc. to host a dinner event with a variety show, exhibiting talent from its surrounding area, on September 14, 2013 at the Clayton County International Park.

Section 2. The Board of Commissioners hereby authorizes the Chairman to execute any documents necessary and otherwise to perform all other acts necessary to accomplish the intent of the Resolution.

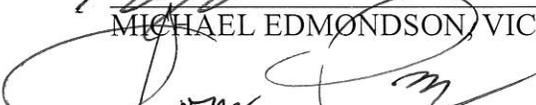
Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
