RESOLUTION NO. 2014-226

A RESOLUTION TO ENTER INTO A LICENSE AGREEMENT WITH GEORGIA STRATEGIC ALLIANCE FOR NEW DIRECTIONS AND UNIFIED POLICIES, INC. (GEORGIA STAND-UP) TO HOST THE “VOTEFEST” COMMUNITY EVENT AT THE VIP COMPLEX AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Georgia Strategic Alliance for New Directions and Unified Policies, Inc. (the “Promoter,” also known as Georgia STAND-UP), in conjunction with Friends of Clayton Transit, wish to utilize the VIP Complex at the Clayton County International Park (the “Location”) to host a community event entitled “VoteFest,” a community outreach event designed to register, educate and mobilize County voters on the upcoming transportation referendum item to appear on the November 4, 2014 ballot; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on September 28, 2014 from approximately 10:00 A.M. until 8:00 P.M., with the purpose of providing citizens a place to be educated and entertained in a family-friendly atmosphere that will include music, food, games, booths and information tables; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with Georgia Strategic Alliance for New Directions and Unified Policies, Inc. (the “Promoter” and also known as Georgia STAND-UP), providing for the terms and conditions under which the Promoter, in conjunction with Friends of Clayton Transit, will utilize the VIP Complex at the Clayton County International Park on September 28, 2014 to host a community event entitled “VoteFest,” a community outreach event designed to register, educate and mobilize County voters on the upcoming transportation referendum item to appear on the November 4, 2014 ballot. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment “A” and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.


