RESOLUTION NO. 2014-327

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE CLAYTON COUNTY BOARD OF HEALTH PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH IMMUNIZATIONS AND HEALTH SCREENINGS FOR SENIORS WILL BE ADMINISTERED DURING THE CLAYTON COUNTY SENIOR SERVICES DEPARTMENT'S HEALTH AND WELLNESS EVENTS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Director of the County's Senior Services Department ("CCSS") has expressed interest in collaborating with the Clayton County Board of Health ("BoH") to define the relationship between CCSS and BoH as it relates to the implementation of CCSS Health and Wellness Events; and

WHEREAS, CCSS desires to partner with BoH, and BoH desires to partner with CCSS, to promote a healthy lifestyle in the senior adult population and program participants of the Kinship Care Resource Center of Clayton County; and

WHEREAS, CCBH will provide immunizations and health screenings during CCSS Health and Wellness events, provide medical personnel to administer health screenings and recommended dosages of vaccine at locations determined by CCSS, and determine each participant's cost of immunization not covered by Medicare or other insurance, with no financial impact on the County's Budget; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into a Memorandum of Understanding as contemplated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into a Memorandum of Understanding, on behalf of the Clayton County Senior Services Department (“CCSS”), with the Clayton County Board of Health, providing for the terms and conditions under which immunizations and health screenings for seniors will be administered during CCSS Health and Wellness Events. The Board of Commissioners hereby authorizes the Chairman to execute the Memorandum of Understanding and perform all other acts necessary to accomplish the intent of this Resolution. The Memorandum of Understanding shall be substantially in the form attached hereto, subject to such minor changes, insertions or deletions as the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


