~~A RESOLUTION TO READOPT THE CLAYTON COUNTY EMERGENCY OPERATIONS PLAN; TO AMEND THE PLAN BY ADDING “ANNEX F – FOOD SERVICES” AND “ANNEX G – WARMING/COOLING CENTER ACTIVATION”; TO AUTHORIZE THE CHAIRMAN TO PERFORM ANY ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.~~

WHEREAS, in 2001 the Board of Commissioners authorized the implementation of a comprehensive Clayton County Emergency Operations Plan (“EOP”) to ensure the preparedness, mitigation, appropriate response and timely recovery from natural or man-made disasters or emergencies affecting Clayton County; and

WHEREAS, the County’s EOP was most recently revised on March 31, 2014; and

WHEREAS, Georgia Emergency Management Agency recommends that local governments readopt their respective EOPs every four years; and

WHEREAS, recent emergency events have revealed the lack of an ability to provide for the nutritional needs of emergency response and support personnel while responding to emergencies and/or disasters; and

WHEREAS, amending the County’s EOP by adding “Annex F – Food Services” will provide basic guidance for all participants in EOP activities including all County departments and agencies providing assistance in responding to emergencies and/or disasters; and

WHEREAS, the Board also recognizes that extremely cold and extremely hot weather conditions can cause serious or life threatening health risks for the County's residents; and

WHEREAS, amending the County's EOP by adding "Annex G – Warming/Cooling Center Activation" will allow Clayton County Emergency Management Agency to identify and designate certain facilities that may be used during an extreme weather event; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by readopting and amending the EOP for the reasons contemplated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby readopts the Clayton County Emergency Operations Plan. The Board also amends the Plan to include "Annex F – Food Services" and "Annex G – Warming/Cooling Center Activation". The Board authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution. The Board further authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


