RESOLUTION NO. 2015-120

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AGREEMENT WITH THE CENTER FOR PUBLIC SAFETY EXCELLENCE PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH CLAYTON COUNTY FIRE AND EMERGENCY SERVICES WILL APPLY FOR NATIONAL ACCREDITATION; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT THE APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Fire and Emergency Services wishes to obtain prestigious national accreditation; and

WHEREAS, once accreditation is accomplished, there is also a strong possibility that the County's ISO rating can be reduced to a class two.

WHEREAS, successful accreditation would lower insurance rates for all businesses and residents in unincorporated Clayton County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into an Agreement with Center for Public Safety Excellence for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into an Agreement with the Center for Public Safety Excellence providing for the terms and conditions under which Clayton County Fire and Emergency Services will apply for national accreditation. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and otherwise perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect the appropriations and expenditures relating thereto. The Agreement shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.

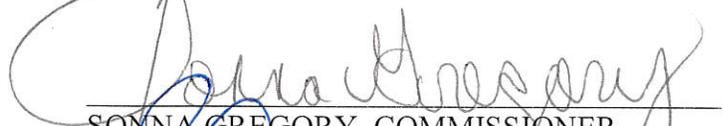
