RESOLUTION NO. 2015 – 199

A RESOLUTION OF THE CLAYTON COUNTY BOARD OF COMMISSIONERS DIRECTING ALL COUNTY RELATED BOARDS AND AUTHORITIES WITH MEMBERS APPOINTED BY THE BOARD OF COMMISSIONERS TO SUBMIT MINUTES TO THE COUNTY COMMISSION CLERK WITHIN 30 DAYS OF MEETINGS PURSUANT TO THE GEORGIA OPEN RECORDS ACT, O.C.G.A. § 50-18-70 ET SEQ.; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners appoints members to a number of County related boards and authorities; and

WHEREAS, these boards and authorities carry out governmental functions and are therefore subject to the Open Meetings Act as codified in O.C.G.A. §50-14-1 et seq.; and

WHEREAS, in accordance with the Open Meetings Act, these boards and authorities are required to prepare minutes of all open meetings which must be made available for public inspection; and

WHEREAS, these boards and authorities are subject to the Open Records Act as codified in O.C.G.A. § 50-18-70 et seq.; and

WHEREAS, the Board of Commissioners wishes to ensure the general public has access to all minutes of any County related boards and authorities; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by directing all County related boards and authorities to provide copies of meeting minutes to the County Commission Clerk within 30 days of the meeting for posting on the County's website.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby directs all County related boards and authorities with members appointed by the Board of Commissioners to submit meeting minutes to the County Commission Clerk within 30 days of the meeting per this directive and pursuant to the requirements of the Open Records Act, O.C.G.A. § 50-18-70 et seq. The Board also directs the Clerk to send copies of this Resolution to the Chairperson of each County related board and authority upon its approval by the Board of Commissioners.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
