RESOLUTION NO. 2015 - 242

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT GRANT FUNDS FOR THE PURPOSE OF JUDGE GERONDA CARTER ATTENDING A TRAINING COURSE ON HANDLING CAPITAL CASES; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Judge Geronda V. Carter has a capital case currently pending in her division; and

WHEREAS, Judge Carter wishes to attend a course on capital case management conducted by the National Judicial College; and

WHEREAS, Clayton County applied for grant funds through the State Justice Institute and has been awarded funding in the amount of \$1,000.00, with no match of local funds required; and

WHEREAS, the grant will cover the tuition to attend the course; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will be served best by accepting the grant for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED



The Board of Commissioners hereby authorizes Clayton County to accept grant funds in the amount of \$1,000.00, with no match of local funds required, to pay the tuition costs for Judge Geronda V. Carter to attend a course on managing capital cases. The Board of Commissioners authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Chief Financial Officer to


amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




