RESOLUTION NO. 2015 - 300

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO EXECUTE A LICENSE AGREEMENT WITH CARRIE LYNN GRAZETTE CANCER FOUNDATION, INC., TO HOST A FUNDRAISER AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request (the "Request") from Carrie Lynn Grazette Cancer Foundation, Inc. (the "Promoter") for use of the Bermuda Pavilion and the Upperfield at the Clayton County International Park (the "Park") for the purpose of hosting a fundraiser; and

WHEREAS, the Park space will be utilized between the hours of 9:00 a.m. to 8:00 p.m. on Sunday, May 29, 2016; and

WHEREAS, the Director of the Parks and Recreation Department recommends that Promoter pay the half price rate for the Special Event Fee (\$350.00), half priced rental fee for the Bermuda Pavilion (\$150.00), and will pay for the services of one coordinator (\$20 per hour for twelve hours—\$240.00), one maintenance employee (\$10 per hour for ten hours—\$100.00), and two Clayton County Police Officers for security purposes (\$45 each per hour for nine hours— \$810.00) during the event, for a total payment of \$1650.00 to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Park space and executing a license agreement for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to execute a license agreement with Carrie Lynn Gazette Cancer Foundation, Inc. to host a fundraiser in the Bermuda Pavilion and Upperfield at the Clayton County International Park on May 29, 2016, and also authorizes the Chairman to execute the documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 2. Carrie Lynn Gazette Cancer Foundation, Inc. will pay the half price rate for the Special Event Fee (\$350.00), the half priced rental fee for the Bermuda Pavilion (\$150.00), and will pay for the services of one coordinator (\$20 per hour for twelve hours—\$240.00), one maintenance employee (\$10 per hour for ten hours—\$100.00), two Clayton County Police Officers for security purposes (\$45 each per hour for nine hours— \$810.00) during the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by the Clayton County Risk Management Department.


