RESOLUTION NO. 2015-39

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AGREEMENT WITH ATLANTA PYROTECHNICS INTERNATIONAL, INC. PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH FIREWORKS DISPLAYS WILL BE CONDUCTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County desires to have fireworks displays at certain holiday events at the Clayton County International Park, and Atlanta Pyrotechnics International, Inc. wishes to conduct a fireworks display on May 23, 2015 and July 4, 2015, to be held at the Clayton County International Park; and

WHEREAS, the County's Parks and Recreation Department shall have sole responsibility for promoting and providing security for protection at the fireworks display to be held at the Clayton County International Park on May 23, 2015 and July 4, 2015; and

WHEREAS, Atlanta Pyrotechnics International, Inc. is qualified to organize and conduct fireworks displays in a professional, safe and organized manner; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into an Agreement with Atlanta Pyrotechnics International, Inc., for the reasons set forth herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into an Agreement with Atlanta Pyrotechnics International, Inc. providing for the terms and conditions under which a fireworks display will occur on May 23, 2015 and July 4, 2015 at the Clayton County International Park. The Board also authorizes the County's Parks and Recreation Department to promote and provide security for protection at the fireworks display to be held at the Clayton County International Park on May 23, 2015 and July 4, 2015.

Section 2. The Board of Commissioners authorizes the Chairman to execute the Agreement attached hereto as Attachments "A" and "B", including an Insurance Addendum, and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.

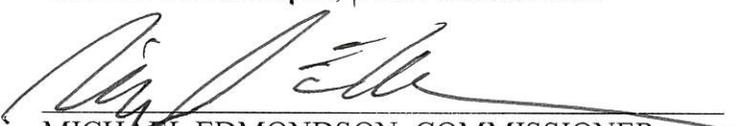

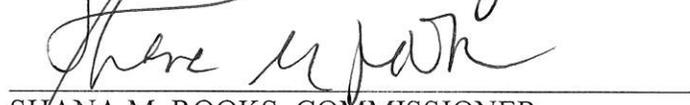
