RESOLUTION NO. 2015-42

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT TO ALLOW ARTHUR MITCHELL TO SPONSOR AND HOST THE “ALBANY FEST ATLANTA” REUNION AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Arthur Mitchell (the “Promoter”) desires to sponsor and host a home town reunion entitled, “Albany Fest Atlanta”, at Clayton County International Park on May 29, 2015 from 9:00 p.m. to 2:00 a.m., and May 30, 2015 from 10:00 a.m. to 8:00 p.m.; and

WHEREAS, this event is to celebrate the city of Albany, Georgia, specifically relating to health, family and careers, and will include a meeting and greet (May 29th), 5K health and fitness walk, Zumba classes, kickball, athletic games and vendors, both promotional and those selling merchandise; and

WHEREAS, the Director of the Parks and Recreation Department (the “Department”) is requesting consideration by the Board of Commissioners to approve the Department’s recommended fees for the event; and

WHEREAS, subject to the foregoing, the Promoter shall have sole responsibility for organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a license agreement to allow the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement to allow Arthur Mitchell (the “Promoter”) to sponsor and host a home town reunion entitled, “Albany Fest Atlanta” at Clayton County International Park on May 30, 2015 from 10:00 a.m. to 8:00 p.m. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment “A” and otherwise perform all acts necessary to accomplish the intent of this Resolution.


Section 2. The Board of Commissioners approves the Parks and Recreation Department’s recommended fees as outlined in the License Agreement, to be paid by the Promoter for the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.


