RESOLUTION NO. 2015-43

A RESOLUTION TO APPROVE A SPECIAL FACILITY USE REQUEST AND TO ENTER INTO A LICENSE AGREEMENT TO ALLOW THE RIVERDALE HIGH SCHOOL COSMETOLOGY DEPARTMENT TO UTILIZE CLAYTON COUNTY INTERNATIONAL PARK, VIP COMPLEX, TO HOST A HAIR SHOW FUNDRAISER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE LICENSE AGREEMENT AND PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Riverdale High School Cosmetology Department (the "Host"), wishes to utilize the Clayton County International Park, VIP Complex (the "Location") to host its annual hair show fundraiser, Friday, May 1, 2015 from 4:00 p.m. until 10:30 p.m.;

WHEREAS, the Host and the Director of the Parks and Recreation Department (the "Department") are requesting consideration by the Board of Commissioners to approve a waiver of the half of the Department's facility use cost of \$700.00 for a Special Event Fee of \$350.00; and

WHEREAS, the Director of the Department desires to enter into a License Agreement for the Host's use of the Location; and

WHEREAS, Clayton County deems it in the best interest of the County and the County will best be served by allowing the Host to facilitate this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby agrees to allow the Riverdale High School Cosmetology Department to host its annual hair show fundraiser at the Clayton

County International Park, VIP Complex, on May 1, 2015. The Board authorizes the Chairman to execute the License Agreement and perform all other acts necessary to accomplish the intent of this Resolution. The Agreement shall be subject to minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. The Board of Commissioners approves a waiver of half of the Parks and Recreation Department's facility use cost of \$700.00 for a special event fee of \$350.00.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the event date as provided by the Clayton County Risk Management Department.
