RESOLUTION NO. 2016 - 10

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT GRANT FUNDS FOR TUITION COSTS FOR ATTENDING NATIONAL DRUG COORDINATOR TRAINING; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the National Drug Court Institute is presenting a National Drug Coordinator Training; and

WHEREAS, Clayton County Courts Administration wishes to send the Accountability Courts Coordinator to attend the training; and

WHEREAS, the training will teach the skills necessary to elevate the level of services provided to the citizens of Clayton County; and

WHEREAS, the County wishes to accept grant funds in the amount of \$1,000 from the State Justice Institute to cover the costs of tuition; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will be served best by accepting the grant for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS


OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept grant funds in the amount of \$1,000.00 from the State Justice Institute, with no match of local funds required, to pay the tuition costs for the Accountability Courts Coordinator to attend a drug court coordinator training course. The Board of Commissioners authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


