RESOLUTION NO. 2016 - 121

A RESOLUTION TO ENTER INTO A LICENSE AGREEMENT WITH RUSH EVENTS ATL, LLC. TO HOST "XTREME WET N WILD" AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT APPROPRIATE REVENUE SOURCES AND EXPENSES, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Rush Events ATL, LLC. (the "Promoter") wishes to utilize Clayton County International Park (the "Location") to host an event entitled, "Xtreme Wet n Wild" which will include live music, disc jockeys, food and alcohol vendors and water activities; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on September 11, 2016, from approximately 3:00 P.M. until 11:00 P.M.; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended event rental fees for the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event for the total fee recommended above by the Department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners agrees to allow Rush Events ATL, LLC (the “Promoter”) to host the “Xtreme Wet n Wild” event to be held on September 11, 2016, at the Clayton County International Park (the “Event”). The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto, and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the Parks and Recreation Department’s recommended fees as outlined in the License Agreement, to be paid by the Promoter for the Event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the date of the Event as provided by the Clayton County Risk Management Department.
