RESOLUTION NO. 2016 - 126

A RESOLUTION OF THE CLAYTON COUNTY BOARD OF COMMISSIONERS AUTHORIZING AN ADDITIONAL DAY OF ADVANCE VOTING WHEREIN ELECTORS MAY VOTE IN THE JULY 26, 2016, PRIMARY RUNOFF ELECTION; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners has determined that an additional day of advance voting is needed in conjunction with the July 26, 2016, Primary Runoff Election; and

WHEREAS, the Board has determined that the Clayton County Elections & Registration Office will be open to allow electors to participate in early voting to be held on Saturday, July 16, 2016, from 9:00 a.m. to 4:00 p.m.; and

WHEREAS, the Board hereby authorizes the use of these facilities to better accommodate the voters and the parties conducting the Primary Runoff Election; and

WHEREAS, the Board deems it to be in the best interest of all parties in Clayton County to add an additional day of advance voting to provide for the general convenience of electors, as well as to facilitate increased voting within the area precincts.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes an additional day of advance voting to be held on Saturday, July 16, 2016, from 9:00 a.m. to 4:00 p.m. The Clayton County Elections & Registration will be open to allow electors to participate in early voting during this time. The Board authorizes the Chairman to perform all other acts necessary to accomplish the intent of

this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective upon the date of its approval by the Board of Commissioners.
