RESOLUTION NO. 2016-132

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO REIMBURSE A STERILIZATION FEE PAID BY SHARON RENEE DOCHIN; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Sharon Renee Dochin adopted a female Australian Shepherd mix from the Clayton County Police Department Animal Control Unit and paid a \$40.00 sterilization fee; and

WHEREAS, it was later determined by a licensed veterinarian that the animal had previously been spayed; and

WHEREAS, Sharon Renee Dochin has requested reimbursement of the sterilization fee; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County to reimburse the fee.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to reimburse Sharon Renee Dochin for a sterilization fee in the amount of Forty Dollars and 00/100s (\$40.00). The Board of Commissioners authorizes the Chairman or his designee to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






