4. *New Business*

A. Certification of Election – General Primary and Nonpartisan General Election held May 22, 2018

Director Dozier informed the Board that there was a 15.5% turnout for the 2018 General Primary and Nonpartisan General Election. In 2014, there was 14.8% turnout for the General Primary and Nonpartisan Election.

Director Dozier informed the Board that there was an increase in the number of voters that voted between 2014 and 2018. In 2014, there were 18,521 voters that casted ballots. In the 2018 election, there were 23,888 voters that casted ballots.

Director Dozier informed the Board that during advanced voting, there were approximately 6,300 voters to cast a ballot, 266 Absentee ballots by mail, and 44 accepted Provisional ballots.

Director Dozier informed the Board that she petitioned Judge Rooks to extend the hours of MO 02, Morrow Municipal Complex and RD 04, Harper Elementary School due to the delayed opening of the precincts.

Director Dozier informed the Board that there will be a General Primary runoff on July 24, 2018.

Director Dozier informed the Board that Advanced Voting will begin July 2, 2018.

Director Dozier informed the Board that a Primary Runoff is a continuation of the General Primary therefore if a voter cast a ballot in the party primary, the voter will vote the same party in the runoff. Director Dozier informed the Board that if a voter has not voted or selected a nonpartisan ballot for the Primary General Election, then the voter has the option to select a party preference for the Primary Runoff Election.

**Motion made by Board Member Ash, seconded by Board Member Givens, to accept the recommendation made by Director Dozier to certify the General Primary and Nonpartisan Election held on May 22, 2018.**


