1. Chair called the meeting to order.
2. Moment of silence observed.
3. Adoption of Agenda:

**Motion made by Board Member Diane Givens, seconded by Secretary Ash. Vote Unanimous. Motion carried.**

4. *PUBLIC COMMENT: Citizens will be given a three minute maximum time limit to speak before the Board of Elections and Registration about various topics, issues, and concerns. Public comments will be limited to thirty (30) minutes. Following thirty minutes of hearing from the public, the Board of Elections and Registration will allow the remainder of citizens who have signed up to be heard at the next regular business meeting.*

A. There were no comments made by the public.

5. *New Business*

A. Certification of Election – General Primary Runoff Election held July 24, 2018

Director Dozier informed the Board that there was a 5.3% turnout for the 2018 General Primary Runoff Election, however in the last like election, there was a 5.68% turnout.

Director Dozier informed the Board that there was an increase in the number of voters since 2014 by a total of 1,353 and that there was an increase of 33,441 registered voters from 2014 until 2018.

Director Dozier commended to the Election Team for their hard work and exceptional job performance during the 2018 July General Democratic and Republican Primary Runoff Election, as well as the 2018 May General Primary and Nonpartisan Election.

Director Dozier further commended Mr. Scott Brown, who has been serving in the role of an Election Technician as a Temporary Employee.

Director Dozier informed the Board that Elections & Registration Staff are in the process of reviewing more ways to increase productivity, and improve poll worker training as the office prepares for the November General Election.

Director Dozier informed the Board that she has received verbal compliments on the Staff's Performance in Poll Worker Training, Election Day and the Election Night.

Director Dozier informed the Board that the Election Night Reporting (ENR) Software was used as the sole source of election night reporting for this Election, instead of the Department of Information Technology scrolling method in order to improve the view of election night results.




