### Old Business

Becky Sheffield asked for a status update for a rescheduled work session for the board to work on language for spay/neuter ordinance. Staff Attorney, India Mitchell indicated that information needs to be sent to her so that language is in proper legal form. There was clarification on why the scheduled work session was cancelled in August due to schedule conflicts and the need for review time. Captain Turnipseed suggested that the board send items for discussion to each other prior a work session and have concise ideas together before the meeting. Becky Sheffield mentioned that she felt that input from CCAC Staff will be important as to the feasibility of certain aspects of this type of ordinance. It was agreed that a combination of emailing and in person communication will be needed going forward and a new work session to be planned as new business.

#### New Business

An Adoption Event is planned for October 7<sup>th</sup> at 10:00 am at the Anvil Block location.

A work session will be scheduled by the board in conjunction with legal and CCAC staff to continue work of possible spay/neuter for Clayton County. This was approved by unanimous vote.

Myla Chapman said she sees many puppies for sale online and asked if they are registered breeders. Captain Turnipseed replied that there are no registered breeders at all in Clayton County and there is not enough staff members at this

point to investigate. They do have one staff member whose duties include investigation, however they are primarily used to investigate cruelty cases at this time.
