# <u>Land Bank Minutes – February 26, 2019</u>

Meeting called to order at 6:08 pm.

**November 27**<sup>th</sup> **Meeting Minutes** – Motion to approve by Fredalyn Frasier and seconded by Artie Jones. Unanimous.

Discuss Meeting with Board of Education – Discussed the required notice to the BOE

**Discuss Board Make-up (odd number of members)** – 10 members now; law requires and odd number; should members from Lovejoy be included? Board of Education? Should a non-voting advisory Board be created?

**Discuss Meeting with City of Forest Park** – good meeting; reiterated the Land Bank purpose; Fredalyn Frasier recommended that the Land Bank reports its dealings to all City Councils.

**Discuss Meeting with Tax Assessor and Tax Commissioner** – Discussed accounting issues, assessed values, and detrimental properties

**Discuss Land Bank Roundtable Tele-Conference** – Introduced Blake Meadows; GALBA is trying to be more efficient and instituted a monthly call to improve communication.

Discuss Withdrawal of Bid Procedure (If Any) — at the last meeting, a winning bidder withdrew after the meeting, leaving the awarded properties available again; discussion of making sure that this doesn't happen again and possibly introducing punitive measures against bidder; Should they have to pay earnest money? A non-refundable application fee? It was suggested to look at other banks and see what they do. Should an escrow account be set up? How would the accounting for the escrow account work? Should a disclaimer for proof of funds be prepared for potential bidders? Should these type of bidders be prohibited from future bidding for a specified amount of time? Artie Jones said that more research be done. Terrance Moore made a motion to do research on procedure for best practices. Fredalyn Frasier said that the standards should apply to current applications.
